Adding all the respondents EoP [Swiss Federal Council](#) and [International Criminal Court](#) respondents to the [Commonsism Map](#) before beginning to notify the cities is going to take a while. I also have not begun – let alone finished - notifying the World Economic Forum respondents of the Radical Honoursty –v– Bilderberg Group & World Economic Forum complaint filed with [Austria Federal Police](#).

So I shall interrupt aforementioned [Acting MILED Clerk administrative closure duties](#), and notify the following 25 countries that I shall be adding their cities to the [EoP Military Necessary Evacuation](#) lotto; should the EoP Axis authorities wish to get started with implementing the EoP lotto evacuations.

Twenty Five Countries whose cities are to be added to [EoP Military Necessary Evacuation](#) lotto are respectively the top five countries for [nominal GDP](#): United States, China, Japan, Germany, United Kingdom, [GDP per capita](#): Qatar, Luxembourg, Singapore, Brunei, Kuwait; [largest cities](#): Brazil, South Korea, Mexico, Phillipines, India; [population density](#): Monaco, Vatican City, Bahrain, Malta, St. Maarten; and [fertility rates](#): Niger, Mali, Burundi, Somalia & Uganda.

National and city administrators shall be provided a copy of this correspondence; which includes the following copies of prior correspondence on these issues for city administrators and residents EoP-Axis Oath decision-making consideration.

1. EoP Military Necessity Mutual Coercion Evacuation Information: [Excerpt: Text Draft [PDF](#)]

Mutual Coercion to Whom:

* City Administrators of cities with populations greater than 25,500 residents. [A City's must be separated by a green corridor of minimum 5 miles; between itself and neighbouring 'city' to be considered a second 'separate city' for the purpose of 'resident counting'; and the green corridor should be 25 miles from any third city.]

* All individuals and their biological children; in aforementioned cities who practice any of the following licensed professions:

→ Lawyers | Psychologists / Psychiatrists | Media: Print, TV or Radio: Journalists / Editors / Producers

* All individuals in aforementioned cities who practice any form of organized religious worship or charity with State non-profit status.

* Breeding / consumption war [scarcity combatant](#) extremist: Any adult individual over the age of 18 who qualifies as an extremist Scarcity Combatant: i.e. any individual who has co-procreated more than 3 biological living children with War is Peace cultural status; any individual whose capital assets amount to more than US \$ 2.55 million.

City Administrators:

City Administrators are to notify the 'EoP Axis of Mutual Coercion' officials from: USA: Pentagon; Russia: Kremlin; EU: NATO; China: People's Army; by 11 September 2015 or a subsequent date to be decided once draft is finalized; in a written statement under oath; of (a)

your city's legal commitment to unconditionally cooperate to implement an [Ecology of Peace](#) international law social contract; or (b) the date by when they shall provide the 'EoP Axis of Mutual Coercion' authorities, with their legal objection arguments and evidence; objecting to the implementation of an Ecology of Peace international law social contract for humane and orderly depopulation and deindustrialization; which should include: the exact date by when the city shall be providing the 'EoP Axis of Mutual Coercion' with your cities detailed plan for orderly and humane depopulation of your city to below 25,500 citizens.

Any city whose administrators fail to notify the 'EoP Axis of Mutual Coercion' as required by the required date; shall be added to the 'EoP Military Necessity Mutual Coercion ICC Option' Lotto.

Lawyers | Mental Health | Organized Religion & Charity Non-profits | Media | Scarcity Combatant Extremists:

Any individual living in a city with more than 25,500 residents; who fits the aforementioned profession and/or breeding/consumption war scarcity combatant status is to notify their city Mayor's office or an individual or office appointed by such Mayor's office; by the required date; in a written statement under oath; of (a) their legal commitment to unconditionally cooperate to implement an [Ecology of Peace](#) international law social contract; or (b) the date by when they shall provide the 'EoP Axis of Mutual Coercion' authorities, with their legal objection arguments and evidence.

Any individual who fails to notify their city administrators; as required by the required date; shall be added to the 'EoP Military Necessity Mutual Coercion ICC Option' Lotto.

EoP Military Necessity Mutual Coercion ICC Lotto Evacuation:

The EoP Military Necessity Mutual Coercion ICC Lotto shall be drawn by the Acting Clerk every second month on the 26 of the month; totalling two ICC lotto nations; excluding nations who have provided ‘EoP Axis of Mutual Coercion’ authorities with their National EoP-Axis Oath.

In the subsequent two months Pentagon and Kremlin authorities shall implement the **EoP Military Necessity Mutual Coercion ICC Option Lotto Evacuation** in all of the two ICC lotto nations cities; where ½ of the nations Lawyers, Mental Health, Organized Religion & Charity Non-profits, Media and Breeding / Capital War Scarcity Combatant Extremists and all their biological children; who have not signed an EoP-Axis oath; shall be evacuated/raptured from Planet Earth by means of military psychotronic technology. Put simply they will be given an instant heart-attack or stroke; or the simple quick and humane termination of their living organs; their dead bodies shall not be buried in cemeteries; but dumped in former grain silo’s to be converted to compost.

The **‘EoP Military Necessity Mutual Coercion ICC Option’ Lotto Evacuation** shall continue until all nations on the planet have notified the ‘EoP Axis of Mutual Coercion’ authorities of their unconditional cooperation; and the international implementation of an Ecology of Peace international law social contract can proceed via any one or a combination of [Ecology of Peace New World Order international law social contract options](#).

The four EoP Axis nations are only to be excluded from the lotto once all of their city administrators have provided their national authorities with their City EoP-Axis oath; thereby providing the EoP Axis nations the mandate to declare their cities and citizens to be EoP Axis consenting cities and citizens; and subsequent thereto: to exclude their nations from the lotto.

Amending the lotto, from a ‘city’ lotto to a ‘nation’ lotto; shall hopefully provide the targeted scarcity combatants of all nations with a greater decision making incentive to unconditionally cooperate with EoP Axis authorities to implement an Ecology of Peace international law social contract; sooner than later.

As I notify cities that they have been added to the EoP Axis Evacuation Lotto; I shall include the notification documentation in Cities Lotto Notice [\[PDF\]](#). I shall also update the [Commonsism Map](#) with EoP Axis oaths and City Lotto Notice info; at least until EoP Axis Officials decide on a more appropriate official alternative where EoP Axis individual and city oaths can be documented.

I imagine Individuals and Cities decision making shall be based upon a combination of: (a) their own cultural decision making process; whether based on non-violent reason and logic reality or threat of force coercion; (b) if the former: Their EoP Oath decision making shall require information clarifying how and why EoP Axis Authorities should be supported to implement an Ecology of Peace international law social contract; that restricts all the worlds citizens to procreating and consuming below ecological carrying capacity limits; (c) if the latter: Their EoP Oath decision making shall require information clarifying that EoP Axis Authorities have access to (i) technologically capable of evacuating one or ten thousand or more pre-selected individuals from the planetary genepool by HAARP technology; and (ii) if so: would use it evacuate more than a few individuals at a time; to the extent of an entire city or cities.

[2] Respondent Nations National Government's may exempt your nation from the EoP Axis Military Necessity Evacuation Lotto pool; by (i) Nations National Government providing 'EoP Axis of Mutual Coercion' authorities with their Nations verified National EoP Axis oath commitment of unconditional cooperation; and (b) Nations Chief Prosecutorial Authority: Attorney General / Director of Public Prosecutions files their written (i) consent or (ii) objection with the International Criminal Court registrar consenting to or opposing the [EoP PoW's -v- Nobel Committee & Peace Laureates et al](#) Crimes of Aggression Acts of War private prosecution proceedings; which must be received and verified by the Acting Clerk 5 days prior to the next scheduled lotto drawing; in order for nation to be exempted from lotto evacuation pool.

Electronic Service per email to a US citizen is lawful in terms of (I) the South African Electronic Communications and Transactions Act. 2002 (Act No. 25 of 2002) and (II) Federal Rules of Civil Procedure Rule 4(f) which allows for service "by other means not prohibited by international agreement as directed by the court," as implemented in *Rio Properties, Inc. v. Rio Intern. Interlink*, 284 F.3d 1007 (9th Cir. 2002) which established that e-mail was an effective means of communication between parties, and that messages sent to the respondents would serve the purposes of notifying them of the pending litigation. Moreover, there is no indication that service in this manner would contravene any international agreement. Finally courts "have upheld service via e-mail, [in] cases involving e-mail addresses undisputedly connected to the defendants and that the defendants used for business purposes." (*Ehrenfeld v. Bin Mufouz*, 2005 WL 696769 (S.D.N.Y., March 23, 2005))
